Continued responsibility for the safe and secure administration of all church assets and property.

Ensured facilities and buildings are insured, in good condition, well maintained, and used for appropriate purposes.

Management of general and specific restricted funds belonging to the congregation.

Maintained an Investment Committee to manage and oversee our investments, particularly the Manse Capital Fund.



### Stewardship & Finance

Oversaw Property and IT Teams as well as Board of Trustees.

Liaised with the Humber Valley Foundation.

Ensured HVUC could fund financial obligations to staff, building maintenance, the wider United Church & community.

Operated at a deficit of just under \$21,000, short of budget forecast of \$59,000, due to grants and incredible financial support from membership.

### Pastoral Care

Together with Elders, kept in regular contact with the sick, bereaved and isolated.

Sent regular notes, cards and packages to seniors in residences.

Extra support list compiled for funerals, weddings, etc.

Partnership being built with Parkland on Eglinton including services being played on their TV channel.

DVDs of services sent to Scarlett Heights.

Revera Kingsway shows HV's services in common area.

Offered Life After Loss Bereavement Support program.

### Daily Bread Prayer Group

Major themes and topics explored were praying scripture, drawing scripture and guided meditation through scripture.

Took part in a series of Lenten reflections.

Further explored anxiety management and mindfulness, meditation,

forgiveness, finding God when things are tough, service/helping others, gratitude, and all forms and styles of music to enhance prayer and spiritual growth.

Many different voices of theology were investigated and studied.

Attendance averaged 16 people, 3 days per week.

Have met 400+ times since March 2020.



### Seniors 55+

Key personnel, Anne and Beverley, could be retained due to grants received.

New programs developed including: Aging Well; Walking Meditation; In the News; Time for Tea and Memoir Group.

Existing programs continued, including: Book Club; Keep Fit; Chair Yoga; Hatha Yoga; Seated Dance, the original Memoir Group and Art/Nature.

Growing participation from HVUC's congregation and the community.

Essential volunteers delivered Daytimers and MabelleArts meals and care kits.

Volunteer-led programs included: Memoir Group; Book Club; Men's Discussion Group; Coffee Time; Fred Torrie Lunch.

"Pop-ups" for outreach included: Silver Creek Park; Parkland and Tapestry seniors residences; M.P. Yvan Baker's Seniors' Programs and; UCC Conferences.

Partnerships developed with community groups, including: Dorothy Ley Hospice; Arts Etobicoke; Neilson Park Community Centre; Backlane Studios.

Donations were received for general 55+ programs, Daytimers and MabelleArts.

### **PROPERTY**

Focus on ensuring our two tenant schools functioned safely.

Ensured electrical and wifi connections operational for new digital church signs.

Helped maintain COVID protocols.

Minor repairs to roof.

No major improvements undertaken due to capital spending freeze.

Retirement of Zoran Mrkovic, longtime custodian who continued to support Sunday services.

Dragan Mrkovic remained evening custodian.

Hired commercial cleaning service who undertook a thorough cleaning.

New team set up to look at use of space needs.

Potential increase in wifi capability delayed by shortage of manufacturer components.

We are also charged with the responsibility of liaising with the Humber Valley Foundation headed by Dennis Schettler. Since the Foundation is an independent arms-length corporation, it does not report to the Board.

#### Responsibilities

The S&F team is responsible for insuring that HVUC is able to fund its financial obligations to our staff, to the maintenance of our building, to the wider United Church and to the community we serve.

### **2021 Activity**

At last year's AGM, the congregation approved a budget that forecast an operating deficit of nearly \$59,000. We ended the year in a deficit position but, at just under \$21,000, the amount was significantly less than forecasted. By way of comparison, the church operated with a small surplus of \$15,000+ in 2020.

In many ways we have much to be thankful for. Despite the significant impact of COVId-19 on our church activities, Humber Valley essentially operated on a combined breakeven basis over the past two years. Two key factors contributed. The first was the incredible financial support from our membership. The second was the infusion of more than \$100,000 in both federal and provincial government Covid- related support grants.

### Goals for 2022

Not surprisingly, our primary goal for the coming year will be to work with our minister Trevor Brisbin, his staff and with the Board of Directors to manage income and expenses in a supportive but responsible way as they continue on the journey of implementing the transformational vision for Humber Valley LIC.

It is clear that significant governmental COVID-19 grants will not be forthcoming in 2022. Reflecting that, we are asking the congregation to approve a budget deficit that we expect will

be \$100,000 higher than the one we experienced in 2021. To that A few months ago, we started work with our bank to implement end, both staff and volunteer groups have committed to managing their expenses in a responsible manner. It is important to note that while such a deficit is not sustainable over a few years, be assured that we have the financial reserves to support this until the planned transformation begins to bear fruit.

Our last capital campaign was nearly 10 years ago. Given the inevitable needs of an aging building and hoped for expansion of our ministry offerings, plans will soon be underway to launch a new capital campaign sometime this fall in conjunction with our 70th anniversary celebrations.

### Trustees

The Board of Trustees of HVUC is responsible for the safe and secure administration of all church assets and property. This means that we ensure that all church facilities and buildings are adequately insured, are in good condition, are well maintained, and used for appropriate purposes. We also manage general and specific restricted funds belonging to the congregation.

As at December 31st, 2021, the Trustees had \$1,007,088 under administration, with the money held in three funds.

## General and Specific church's use. During 2013 and 2014 \$33,000 and \$100,000 of such funds were transferred.

\$116,550 for loans and expenses judged to be relevant to enhancing the interests and well-being of HVUC. During 2021, there was no transfer from these funds made to the church.

### **Capital Fund**

\$121,920 is the fund held as part of the 2012 campaign "60 and Beyond". This money is to be held while the executive committee decides on its application. Funds raised to Dec 31, 2012 (\$235,000) were transferred to the Trustees to be invested and held for the

church's use. During 2013 and 2014 \$33,000 and \$100,000 of such funds were transferred back to the church. During 2016, additional money was transferred into this fund accounting for most of the increase of \$90,218. During 2018, the Trustees transferred \$125,000 from this fund to support the operations of the church. There were no transfers from this fund made to the church in 2020 and 2021.

### Manse Capital Fund

\$768,618 is held in trust and part of it is restricted per the current rules of the United Church of Canada, and all

related investment income is used solely to augment/support HVUC ministerial costs. These activities allowed the Trustees to contribute \$24,317 in 2021 to cover ministerial costs.

The Trustees maintain an Investment Committee to manage and oversee our investments, particularly the Manse Capital Fund.

# HUMBER VALLEY UNITED CHURCH NOTES TO THE FINANCIAL STATEMENTS OF THE BOARD OF TRUSTEES (prepared without audit) FOR THE YEAR ENDED DECEMBER 31, 2021

#### 1 FUNDS

#### a) GENERAL AND SPECIAL FUND

There are no restrictions on the application of the capital and income of this Fund.

Designated donations and transfers established a capital fund for the provision of loans deemed appropriate and necessary to advance the interests of the congregation.

There are no restrictions on the application of the undesignated bequests.

During 2005, the Fund advanced \$50,000 to ministerial staff as a non - interest bearing loan to facilitate the purchase of a residence. This loan was repaid in 2010.

During 2018, the Trustees approved a special transfer of \$15,000 from this fund to the church

#### b) CAPITAL FUND

During 2012 the church celebrated Sixty and Beyond. Funds raised to Dec 31 2012 (\$235,000) were transferred to the Trustees to be invested and held for the church's use.

During 2013, \$33,000 of such funds were transferred back to the church.

During 2014, \$100,000 of such funds were transferred back to the church.

During 2016, the church received a donation and transferred \$75,842.95 to the Trustees to be invested and held for the church's use

During 2018, \$125,000 of such funds were transferred back to the church.

#### c) MANSE CAPITAL FUND

The Fund consists of the proceeds, less applicable expenses, from the sale of the manse property. As required by the United Church of Canada, the Fund must be accounted for separately, with the investment income therefrom to be used only to provide ministerial housing. Gains on the sale of securities have been accumulated in the Fund.

During 2010 the Board of Trustees received \$203,840 from the Manse Fund formerly held by St. Luke's United Church.

During the year \$24,317 (2020-\$22,520) was paid or accrued as payable to the Church to be applied to housing allowance costs.

# Vision for the Future Rev. Dr. Trevor Brisbin

At Humber Valley United the image of the melting iceberg has resonance. It reminds us of a special time when we were all together. The words harken back to fun, friends and events that make our church so special. "Our Iceberg is Melting" also reminds us of the uncomfortable reality that our church and our world is changing rapidly and the implications for Humber Valley are consequential.

A recent article stated: The UCC (United Church of Canada) is the country's second-largest Canadian Christian denomination. It accounted for 14.6 per cent of Canadian Christians in 1985. In 1996, that number declined to 9.7 per cent and to just 3.8 per cent in 2019.

Global News, January 8, 2022.

It is estimated that the United Church of Canada closes roughly a church a week. And that isn't expected to slow down.

### Leadership

One way to understand leadership is to recognize leaders are those who see the world as it is and insist "it doesn't have to be this way."

At the HVUC Board Retreat in November, there emerged a clear consensus that now is HVUC's time to lead. We don't have to sit back and accept extinction as our fate. Perhaps now more than ever, this moment is pregnant with potential.

#### **Transformation**

There has been a lot of talk at HVUC about transformation. The reason this has become such a focus is because transformation is what's required if we are to continue in our inspiring tradition of impacting lives.

#### Who

The obvious question that needs answering is 'who' are we going to impact? This is where the reality of our melting iceberg becomes very relevant.

The truth is fewer and fewer people have any inclination toward church. As demonstrated by declining UCC membership, people are running from churches not to them.

#### BUT...

While many churches are facing closure, there are other churches in the GTA that are thriving. Week after week, packed with 20, 30, 40, 50-somethings, excited about their faith, longing for community, desperate to make a difference in the world. Committed to engaging worship, relevant liturgy and authentic teaching, these churches show us there is hope.

### **Reality Check**

As exciting as it is to imagine hundreds (sometimes thousands) of people filling a church week after week, the sad reality is most of the growing churches in the city are theologically conservative, enforcing a narrow view of God, faith, and human sexuality and relationships. They are churches that promise "all are welcome" - yet refuse participation to those who don't fit a narrow ideal of gender or sexual identity.

#### So?

Increasingly, more people who once found meaning in these conservative churches are realizing the harm being inflicted onto LGBTQ2S+ people. Church attenders are beginning to question the morality of belonging to hetero-exclusive communities. Many are beginning to leave.

Their iceberg is melting.

#### The Need

The hardest part for the disenfranchised demographic leaving conservative churches is they aren't done with God or even Christian community. They love the church; they've invested so much into the church. They are best described as not wanting to leave God or church, but needing to leave the small-minded church that once pointed them toward God.

#### The Pill to Swallow

For most leaving conservative churches a United Church would not be considered an option. The cultural and liturgical gap is simply too great. It feels too foreign.

### Superpower

This is our superpower at Humber Valley United. We are uniquely situated to speak directly to these people in ways that resonate. We are a space of theological generosity, inclusion and acceptance, where those looking for an affirming faith community can feel at home.

#### The HVUC Difference

The Board believes a deliberate connection with this demographic is a way to make a real impact on lives. As icebergs melt around us, we have the opportunity to be a lifeboat, inviting the disenfranchised to help us create a more generous space of faith where all gender expressions and sexual identities, can worship, belong and grow in relevant ways.

Lifeboats are never fancy. Their value is not in their complexity but in their proximity and timeliness. This is the time for Humber Valley to reimagine ourselves as a refuge for those seeking exactly what we're good at: dynamic Christianity: radical acceptance: and life-changing community. The trick is, as the world has changed, we too need to change our expectations for how these things can look at HVUC. But maybe that's not too much to ask, because when you're a lifeboat, what matters most are the lives coming aboard.

# Shining Waters

We at Humber Valley need and want to have a strong relationship with the United Church of Canada. A primary way to do that is with our strong relationship with our UCC Region, Shining Waters. In our role, it is our responsibility to keep Humber Valley up to date with the happenings in the Shining Waters Region. Part of our job is to pass along communications to appropriate people and committees within our church, so we can be relevant and engaged with the progressive goals of the United Church of Canada. Gail has been very active as a Pastoral Relations Liaison providing help to churches who need assistance in determining new directions for their ministry. The Region has many committees

that offer support to congregations. We also keep you informed of UCC, EDGE and Regional workshops; several members have recently attended workshops, such as one entitled "Love and Justice: Change and Innovation". UCC and Shining Waters activities are communicated through Essentials emails.

### Pastoral Care

Personal invitations were sent out to the bereaved in December for the Gift of Hope service. The PC team assisted Trevor and Drew with the Gift of Hope service on December 16th. The service as was both live and online.

# Property

#### General

The Property Team spends most of its time maintaining the routine functioning of the church, doing tasks such as fixing fences and worrying about water run-off from the parking lot. With the church closed for most of 2021 and 2021, many of the property tasks were focused on ensuring the two schools could function safely.

During 2021, Property was heavily involved in establishing the electrical and Wi-Fi connections that enable our new church signs to operate. Property is also part of the team that establishes and maintains COVID protocols.

### Freeze on Capital Spending

Given the uncertainty of funding during COVID-19, the HVUC Board froze the Capital budget during 2021. Some minor repairs were made to the roof, but no other Grants from Government major improvements were undertaken.

### **Retirement of Chief** Custodian

After 27 years of taking care of our church, Zoran Mrkovic took a well-deserved retirement in 2021. Zoran's retirement was not only the loss of a capable and skilled person, but the impetus for a complete review of our custodial needs for the foreseeable future. After looking at what other Churches were doing and listening to advice from many, a decision was made that we would engage a commercial cleaning service to meet our needs. We also chose to retain Dragan Mrkovic to

cover evenings and Saturdays, and accepted Zoran's offer to deal with Sunday services.

We recognize that this decision means we do not have regular maintenance/repair staff, and maintenance/repair tasks will have to be dealt with as they arise.

Our new contractors undertook a thorough cleaning of every aspect of the church from rafters and ceilings to basement and sump pits. We then examined the five types of flooring that exist within the church and decided on the appropriate cleaning and care each requires. Each floor type and location were slotted into a major maintenance schedule and we started our new approach to monitor how much use a floor can take before it needs a major maintenance treatment.

# for Capital Projects

With the inability to spend church Capital funds, we have examined all of the current government incentive programs to see if we can find funding for some projects. A particular concern is the large amount of single pane glass in the outside walls of the Church, which expose us to extensive heat loss. Although we reviewed several approaches, we have found the Government dollars that would ordinarily be applied to energy-saving programs, have been redirected to COVID 19 projects. Thus we have not yet benefitted from any incentive programming for window replacement.

Accommodation and Use of Church Study

As we have changed programs, hired new staff and initiated new activities, we have found it timely to step back and take a look at the overall needs of all the users of the church with regard to the allocation of space. Room allotment directly affects staff, volunteers, and renters, as well as ongoing functions and activities within the Church. A new team consisting of the Minister, representatives from the Board, Finance, Room Bookings, Tenant Relations, and Property has been set up to perform this function. Results are expected during the current fiscal year; implementation may require some capital funding.

#### **Thanks**

As always there is thanks owed to many who contribute their time to assist in the delivery of the Property program, and I wish to thank each and every one of you.

### Highlights from 2021 in **Information Technology Equipment**

There has been little change in the past fiscal year in this program. Minor adjustments have kept us current and the system has worked very well. There was an intent to increase the capability of the Wi-Fi system within the church but that project has been delayed by a shortage of components from the manufacturer.

New programs were developed e.g. Aging Well; Walking Meditation; In the News; Time for Tea and a second Memoir Group. Existing programs e.g. Book Club; Keep Fit; Chair Yoga; Hatha Yoga; Seated Dance, the original Memoir Group and Art/Nature

walks remain very popular. Participation continues to grow - more or less equally split between HVUC's Congregation and the Community - both in Central Etobicoke and far distant, thanks to Zoom.

Volunteers remain essential in helping with ever popular Daytimers and MabelleArts programs, both of which involved physically assembling and then delivering meals and care kits. Volunteers are also key to running many programs, e.g. Memoir Groups 1&2; the Book Club; Men's Discussion Group; Coffee Time; Fred Torrie lunches, etc. We are very grateful to our willing and dependable volunteers - many thanks to you all.

Outreach continues to grow with "Pop-ups' at Silver Creek Park and on the HVUC

grounds; with Parkland and Tapestry Seniors Residences; presentations on M.P. Yvan Baker's Seniors' Programs and; at UCC Conferences. Partnerships have developed with local community groups, e.g. Dorothy Ley Hospice; Arts Etobicoke; Neilson Park Community Centre; Backlane Studios, etc. We have experimented with hybrid meetings and are committed to building capacity to provide inclusive programs.

### Communications

2021 was a very busy and eventful year for the Communications Committee.

The final edition of the newsy version of *Keeping in Touch*, number 99, was published on April 15. In addition to keeping the congregation informed and publishing original writing and stories about the church and the congregation it raised more than one thousand dollars in sponsorships. *Keeping in Touch*, redesigned and with a more information/event focus, is continuing to be published on Thursdays, edited by Kelly Wells.

The Committee produced a new logo for the church; approved by the Board. This logo is to be used on all official HVUC documents and is prominent in our promotional materials, social media and on our outside signs.

The HVUC website was redesigned and updated. New banners employing the new logo were designed and uploaded to our social media sites.

Two new electronic signs were installed on the HVUC property in April. The

Communications Committee initiated and led this project. Guidelines for messages on the signs were produced. The Communications Chair and the Chair of the Board ran a campaign to raise funds to pay for a shortfall in the funds required to pay for the signs and related infrastructure. A gardening committee under the leadership of the Communications Chair raised funds, designed the landscaping around the signs, purchased materials, prepared the soil, planted the shrubs and flowers, and made sure they were well watered and fertilized. The lead for the sign ministry was moved from Rev. Trevor to Deb Turnbull.

HVUC summer students completed two projects for Communications: an electronic index to articles in *Keeping in Touch* and a visual inventory of HVUC signage inside and outside the building.

The frequency of *Connections*, the HVUC newsletter was changed from quarterly to monthly starting in May. Colleen Isherwood joined Susanne Hynes as coeditor. A new price structure for ads in

Connections was established and more than \$2000 in advertising was sold for the 2021-2022 year. Readers are encouraged to read Connections electronically but print copies are available to pick up in the church and are being distributed to a list of people who do not have computers. Connections continues to be enthusiastically supported by the congregation. The editors are very pleased that so many people submit contributions that reflect suggested themes and the life of the church.

Drew Brown joined the Committee in September and is responsible for HVUC's social media. Susanne Hynes submitted her resignation as chair as of the end of 2021.

people who die without baptism are in no way condemned, lost, or damned.

Baptism in the United Church is recognized by all denominations of the Christian church that practice infant baptism.

racialized groups, ages, cultures and abilities are able to have a Christian funeral service at Humber Valley United Church.

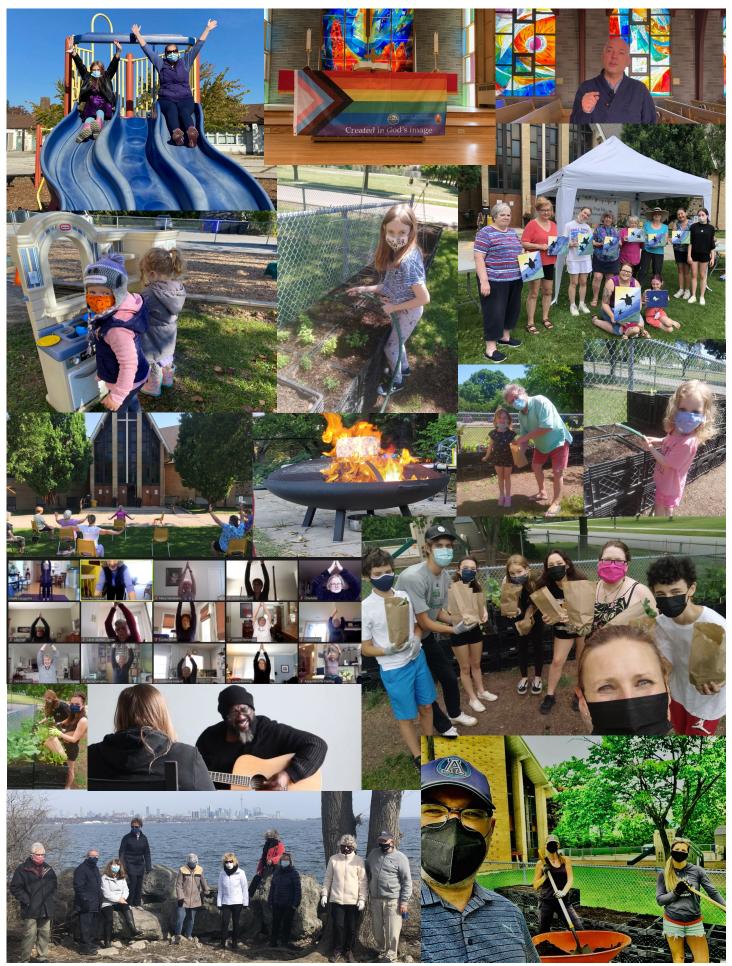

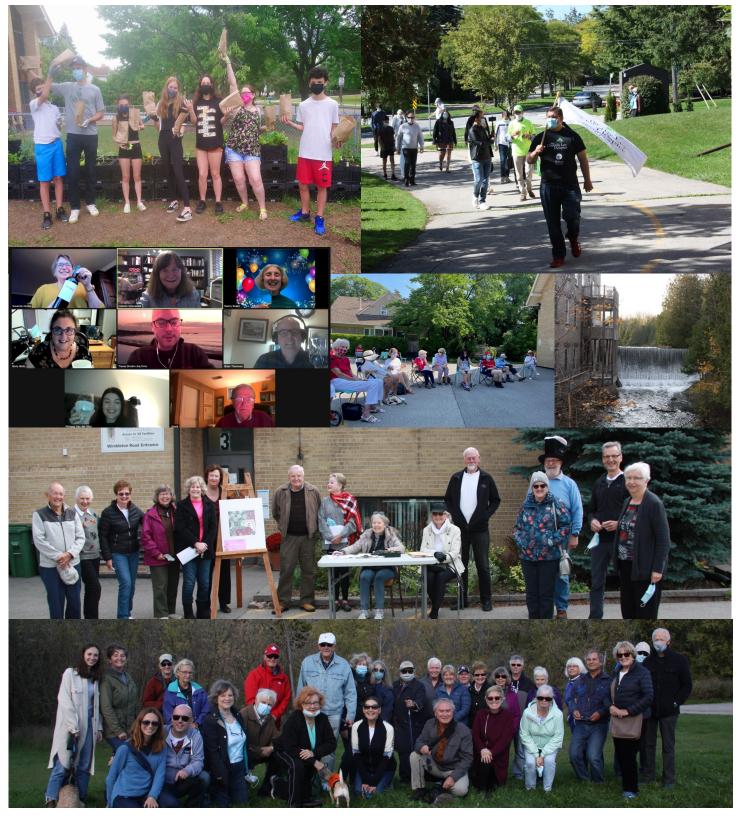
# Marriage Policy
